#### Introduction

Pacific Northwest Pollution Prevention Resource Center (PPRC) is a 501(c)3 nonprofit organization incorporated in the state of Washington in 1990. PPRC is the Northwest Region's largest nonprofit organization that provides on-the-ground technical assistance to local, state, and federal government, communities, nonprofits, businesses, and other partners who are seeking to reduce pollution at its source and improve their economic vitality. Since 2014, PPRC has worked with the Clackamas River Water Providers (CRWP) to deliver technical assistance and outreach to automotive businesses and landscapers using the EcoBiz Certification standards. PPRC has been working with CRWP since 2016 to implement Clackamas River drinking water protection projects.

#### **Project Overview**

During the 2019/20 fiscal year, PPRC contracted with CRWP to continue implementation of drinking water protection projects. The following table outlines the Proposed Tasks and Completed Activities during 2019/20.

## Provide Containment.

Recommend storing your 55 gal oven degreaser drums inside and on spill pallets.

□ Store All Waste Under Cover. To prevent stormwater contamination, store all waste under cover at all times. This includes: scrap metal, used tires, fluorescent bulbs, solid waste, and hazardous waste. Keep the lids on your solid waste dumpsters closed.



□ **Properly Manage Hazardous Waste.** Properly dispose of the old paint cans behind your shop. The EPA, OSHA, and Department of Transportation require hazardous waste to be properly labeled while onsite and during transportation.

PPRC is available to provide a training on ways your employees can help protect the Clackamas River.

□ Follow local washing requirements. State and local regulations prohibit the discharge of pollutants to the storm water system. This includes washing vehicles with soap and hot water. Businesses are permitted to wash up to eight (8) vehicles per week with cold water only. Ensure that all truck rinse water is staying onsite by washing over gravel lot with cold water only.

Recommend discussing wash water requirements with truck washing contractor. Clean Water Services has a fact sheet outlining Oregon DEQ's requirements:
