Introduction

Pacific Northwest Pollution Prevention Resource Center (PPRC) is a 501(c)3 nonprofit organization incorporated in the state of Washington in 1990. PPRC is the Northwest Region's largest nonprofit organization that provides on-the-ground technical assistance to local, state, and federal government, communities, nonprofits, businesses, and other partners who are seeking to reduce pollution at its source and improve their economic vitality. Since 2014, PPRC has worked with the Clackamas River Water Providers (CRWP) to deliver technical assistance and outreach to automotive businesses and landscapers using the EcoBiz Certification standards. PPRC has been working with CRWP since 2016 to implement Clackamas River drinking water protection projects.

Project Overview

During the 2020/21 fiscal year, PPRC contracted with CRWP to continue implementation of drinking water protection projects. The following table outlines the Proposed Tasks and Completed Activities during 2020/21.

Provide technical assistance to ten (10) commercial and industrial businesses	PPRC provided technical assistance and recommendations reports to four (4) commercial and industrial businesses. All of these businesses received environmental assessments and recommendations to help protect drinking water, as well as spill response signs and spill kits (when needed). (See Appendix B for Recommendations Reports). **NOTE: Outreach success rate was reduced due to the COVID-19 pandemic, during which PPRC primarily performed phone and email outreach and offered virtual or distanced in-person assessments.



PROJECT OVERVIEW

Clackamas River Water Providers (CRWP) has partnered with PPRC to provide free technical assistance and tools to businesses located in the Clackamas Industrial Area. ☐ Review and post a spill response plan (see attached for example). Plan should include the procedures for cleaning up various types of spills.

☐Place spill kits in highly visible areas where liquids are stored or transferred. PPRC will provide 2 small spill kits.

Store All Waste Under Cover

PPRC recommends that all waste, including used tires, scrap metal, and solid waste, be covered to prevent stormwater pollution. Temporary uncovered storage of these materials outside can lead to stormwater pollution.





★ Provide Secondary Containment

PPRC recommends that businesses provide secondary containment for tanks and drums 55 gallons and greater (Example: spill pallet, double walled tanks, containment berms), including:



- 275 gallon IBC tote outside ☐ 7 x 55 gallon oil and antifreeze drums inside shop area □ 6 x 55 gallon drums of cleaning chemicals in wash bay
- Tollow Local Requirements for Washing Vehicles State and local regulations prohibit the discharge of pollutants to the storm water system. This includes washing vehicles with soap and hot water.





Hold Annual Meetings/Trainings Refreshers For All Employees

Provide training for employees on the following topics:

- ☐ Know where the Safety Data Sheets (SDS) from products used at your facility are located and how to use them. Proper hazardous material and waste storage. Hazardous waste management techniques. ☐ Spill prevention training: Your facility is within the Clackamas River drinking water protection area.
- * Assign an Employee to Conduct Monthly Audits
 - ☐ Hazardous material storage ■ Waste storage areas
- Create a chemical inventory for your facility

Store next to cerntral storage area for easy access and reference.



Install Storm Drain Markers

Drain markers remind employees and educate customers that site drains to a local waterway and spills can impact your drinking water. PPRC will provide free of charge when shop is ready for final certification.














□ Label All Containers. Make sure all labels are legible and up to date annually. Outdoor drums of washer fluid and degreaser were observed without labels.

PROJECT OVERVIEW

Clackamas River Water Providers (CRWP) has partnered with the PPRC to provide free technical assistance and tools to businesses located in the Clackamas Industrial Area. On **September 22, 2020** PPRC completed a voluntary facility site visit at **Trillium** with Zerelda Beckstead and Jason Allen. The following is documentation of P&A Metal Fab's efforts to reduce potential impacts to the Clackamas River, the drinking water source to over 300,000 people in Washington and Clackamas Counties.

RECOMMENDATIONS

☐ **Provide secondary containment.** Most liquids at Trillium have secondary containment in place. CRWP will provide one 4-drum spill pallet for IPA and / or used oil.







CRWP has containment trays available in the following (internal) dimensions:

- 36 x 36 x 4¾"
- 12 x 48 x 4¾"



If either of these trays will fit underneath Fomblin or Teflon storage areas, or other hazardous materials, CRWP will provide trays.





☐ Mark storm drains. PPRC installed four (4) storm drain markers to help educate employees and the public.

☐ Post spill response signs. PPRC provided four (4) signs to post in areas where liquids are stored and transferred.

- Update spill response plan to include chemicals, spill kits, storm drains, and utilities. PPRC can assist.
- Place spill kits in all areas where liquids are stored or transfered. Each spill kit should have absorbant sock and pads. Optional items include garbage bags for disposal of material after use and PPE (gloves, safety glasses, etc).
- ☐ **Train staff.** CRWP has free training videos and a PowerPoint available on their website, which cover spill response and stormwater / drinking water protection.
