## INTRODUCTION

Pollution Prevention Resource Center (PPRC) is the Nortwest Region's largest nonprofit organization that provides on-the-ground technical assistance to organizations seeking to reduce pollution at its source and improve economic vitality. PPRC has worked with the Clackamas River Water Provider (CRWP) since 2014 to deliver technical assistance and outreach to automotive businesses and landscapers using the EcoBiz Certification standards. PPRC has also been working with CRWP since 2016 to implement Clackamas River drinking water protection projects.

### PROJECT OVERVIEW

During the 2023/24 fiscal year, PPRC contracted with CRWP to continue implementation of drinking water protection projects. The following table outlines the Proposed Tasks and Completed Activities during this fiscal year.

Perform outreach at businesses that could receive hazardous material education and technical assistance.	PPRC contacted and offered technical assistance to 22 commercial and industrial facilities within the Clackamas River Watershed. See Appendix B for Summary of Business Interactions. Article in CRWP Winter 2024 Newsletter promoting program PPRC's work in the jurisdiction.  PPRC staff and Kim Swan, Water Resource Manager for CRWP met quarterly.  PPRC is completing videos under a grant from EPA that will be useful for businesses in the CRWP jurisdiction.



## APPENDIX A - MILES FIBERGLASSING SUCCESS STORY





PPRC worked with Miles Fiberglass & Composites to identify the need for and purchase spill containment equipment. Pictured above are, left to right, the company's reclaiming area before and after install a containment berm. Equipment was purchased by PPRC using funds provided by CRWP.







Pictured above are, left to right, the company's paint storage area before and after installation of spill pallets. Also pictured is purchased utility tray in use. It is clear from these photographs the company was able to clean up trouble spots in the facility. If a spill occurs, these chemicals will be contained and will not reach the Clackamas River. PPRC has also offered a free Pollution Prevention assessment to Miles Fiberglass funded by a grant from Oregon DEQ. This will result continued improvement and reduced hazardous pollution leaving their site.
